F.C. Reed Middle School News from Principal John Truesdell

Dear Community Members,

It's impossible to not be energized by the potential of the 2023 - 2024 school

year! Classrooms are buzzing with activity, fall sports are underway in the crisp evening sunlight, and the mission of F.C. Reed Middle School continues to challenge our faculty to ensure all students acquire the social, emotional, and academic skills that are needed to excel in high school and reach their fullest potential.

In preparation for the upcoming school year, we were busy upgrading the school facilities and participating in numerous professional learning opportunities to support our organizational goals. We have also expanded our program and service capabilities in the area of mental health, which will empower the staff to better support all members of our learning community.

When students and families return in the fall, they will quickly recognize a transformational project at the heart of their school. Over the summer months, the courtyard had over 1,200 wheelbarrows of weeds, gravel and debris removed. Once cleared, the site was then leveled, engineered to properly drain water and then thousands of gallons of fresh concrete were poured. This project will pave the way for a new

outdoor classroom and garden that is over 1,600 square feet in area! Picnic tables, shade umbrellas, and vegetation beds, which will be cared for by the RMS Garden Club, will soon follow to create a new, vibrant gathering space. While outdoors, it's important to note that the space will also be very secure thanks to its fully enclosed perimeter in the building. I look forward to sharing more updates with you all as the year progresses.

While summer is a time for wellness and restoration, RMS teachers invested heavily in professional learning during the summer months. A number of teachers voluntarily went above and beyond and attended out-of-state conferences and/or completed courses related to STEM facilitation, computer science, evidence-based writing, student motivation, cooperative learning, instructional coaching and special education de-escalation techniques. These efforts illustrate how our faculty continues to prioritize our children by modeling what it looks like to be a lifelong learner. Further, it highlights their dedication to facilitating a student-centered learning process that is engaging, empathetic and rigorous for all middle schoolers.

Finally, I am thrilled to announce that we have *dramatically* **expanded our mental health support capabilities** by increasing licensed social worker services from 1.5 days a week to 5 days a week.

This shift will give our student population access to both a full-time school counselor (Mrs. Fast) and a full-time social worker (Mrs. Cooper). The expansion will also allow RMS to implement a premier, comprehensive mental health program that will be a leading model across southwest Michigan. Expanded programming will help more students and parents/guardians have the resources, tools, and services needed to create resilient learners, which is critical in middle school.

As a community, it is our collective responsibility to prepare and support students for lifelong learning. As a new year starts, our faculty looks forward to partnering with all stakeholders to continue to improve our environments, practices, and services to meet the needs of all families.

Strengthening Relationships at Bridgman Elementary School by Principal Lori Graves


All humans are hardwired to connect. Just as we

need food, shelter and clothing, human beings also need strong and meaningful relationships to thrive. In order to enhance the relationships at Bridgman Elementary, our staff will be implementing **Restorative Practices** during the 2023-24 school year. Restorative Practices is a field within the social sciences that studies how to strengthen relationships between individuals as well as social connections within communities.

The foundation of Restorative Practices is that the power of relationships guides behavior. When we feel a part of a supportive community, we respect others in that community and become accountable to it. Restorative Practices value student empowerment and this empowers students to develop intrinsic motivation to make good decisions and form positive relationships.

Bridgman Elementary school will begin to foster this sense of community through daily classroom circles. Circles help students better understand each other, inspiring a sense of empathy and connection. It helps students gain practice in talking with one another in a respectful and honest way. Teachers and staff will create a safe place where students can connect

and explore challenges. Practicing having a good conversation allows for better communication when there is some sort of difficulty or conflict.



In conjunction with Restorative Practices, Bridgman Elementary will be implementing **TRAILS social and emotional curriculum**. TRAILS was founded by the University of Michigan in order to equip schools with training materials to address the social and emotional wellbeing of students. The TRAILS program helps all students develop life skills they need to thrive. TRAILS will teach students to engage in academic learning while fostering such qualities as respect, empathy and self-awareness.

BPS administration, faculty and students will collaborate with BFEE on 2023/2024 project grants that will make an educational difference for students and our community! The Foundation Trustees are community volunteers who experience a sense of satisfaction from the success stories told by Bridgman Public School students and their teachers. BFEE requires grant recipients to provide their feedback on the award outcome through an evaluation form to the project committee. I want to share a summary of the feedback received on the BFEE

\$5,000 grant to support the DECA International Career Development Conference (ICDC). The question/feedback I am highlighting is "what impact has your project had on Bridgman students, your colleagues, Bridgman schools and/or the Bridgman community at large?"

The students who participated on this trip said they are more confident now and enjoyed being in a business setting and having casual conversations with other people from across the country. They said this experience "bettered" their presentation skills and made them more independent as far as managing their schedule. They also take pride in our school. A couple of students said this created more awareness for their project topic, like drunk driving, and one student actually started their own business based on their business plan. A parent/chaperone noted that it was amazing to see DECA full circle at the ICDC competition. I did not know there were categories for scholarships that kids could apply directly with companies in their field of interest. I did not know the amount of work involved to write a paper and land on that stage and be competitive. The number of students competing at such a high level is impressive.

As noted by the DECA grant feedback, the BFEE Trustees can gain a feeling of satisfaction by being

part of the BPS commitment to student success. What makes the DECA grant and all other grants possible is our community, the willingness to donate funds, to give time and to believe in our vision to "inspire students to positively impact their world."

City of Bridgman News from the City Manager, Juan Ganum

The Weko Beach and Campground Facebook page is getting a lot of traffic!

As of August, the page had over 12,000 followers and 11,000 likes. These numbers are equivalent to about five times the total population of Bridgman! In comparison, the City's other Facebook pages for its fire and police departments have about 1,500 and 2,500 followers, respectively.

The City's aim is to utilize its social media accounts to provide timely, accurate and useful information to residents, visitors and business owners. Although Bridgman does not have a social media coordinator as in other cities, its fire chief, police chief, parks and recreation director, city manager and other employees have contributed to the sharing of information for the benefit of the community. We each strive to communicate clearly and effectively so that residents, our primary constituents, are kept apprised of the issues that are most likely to concern them. These matters include public improvement project schedules (e.g. Lake Street Project, Toth Park Playground Project, Bridgman Courtyard), safety precautions (e.g. Weko Beach red flag conditions, flooding) or event information (Weko Beach Summer Concert Series, Makers Trail Festival), among others.

Our administration is currently reviewing its approach to the use of social media in an effort to communicate more effectively. We realize that residents are hungry for information and eager to have relevant and timely news or items of local interest. Additionally, we understand that residents may have questions or seek clarification about something they have read or heard, whether from the City or otherwise. To establish a more open, transparent and constructive relationship with the community, we will review our processes for acknowledging and responding to your inquiries. We want our residents to have the best information available so they can be properly informed and well connected. To that end, please look for improvements and changes to Bridgman's social media presence in the coming months.


To highlight our aim of being more communicative, the information in the chart is in response to a number of comments that have been posted to the Weko Beach and Campground Facebook page over the years, regarding Bridgman's parks and recreation funding structure.

A common misconception is that the City's General Fund, which is supported by property tax dollars, is used to pay for parks and recreation costs. In many cities that is indeed the case, but Bridgman has the advantage of having several revenue generating sources, such as the campground, daily and seasonal beach parking, beach house rental, concessions and

kayak rental. These sources collectively generated over \$740,000 during our most recent budget year (FY 2023). This significant inflow of funding means that the City does not divert a single dollar from its General Fund to cover any parks and recreation related costs, including those in non-revenue generating parks, such as Toth Park.

WEKO BEACH & CAMPGROUND REVENUE BREAKDOWN



The benefit of having a revenue generating governmental operation (called an enterprise fund) is that General Fund dollars (again, mostly local property tax dollars) are saved, while quality of life investments can still be made. By way of example, the Bridgman City Council directed over \$200,000 from the City's parks and recreation funds to develop a new play structure in Toth Park. Without park funds the City Council would not have the financial latitude to direct such a large amount from the General Fund.

Upcoming Election Changes in the State of Michigan

Hello Bridgman residents!

As the 2024 election season approaches, we are on the brink of witnessing significant changes to the electoral process in the state of Michigan. These changes aim to enhance voter accessibility, ensure the integrity of our democracy and strengthen our collective voice.

The cornerstone of a healthy democracy is ensuring that every eligible citizen has the opportunity to cast their ballot. The upcoming election changes in Michigan are committed to expanding voter accessibility. To achieve this, the state is implementing measures required by the passage of Proposal 2022-02.

The implementation of early voting will allow voters to cast their ballots at an early voting site beginning the second Saturday before a state or federal election and ending the Sunday before the election. Furthermore, increased early voting opportunities will offer citizens more choices and reduce long lines at polling stations on Election Day.

Ensuring the security and transparency of our elections is paramount. The election changes in Michigan are designed to safeguard the integrity of our electoral process, promoting confidence and trust

among voters. Additionally, post-election audits will become more transparent, further bolstering the public's trust in our democratic system.

Routine Hydrant Flushing October 2 - 6

The Water Department will be systematically flushing water through fire hydrants throughout Bridgman.

You may experience some temporary effects in your water supply during this period, including:

Changes in water color: The water may appear discolored or cloudy. This is due to the disturbance of naturally occurring minerals in the pipes. Although disconcerting, the water remains safe to use. Running the cold water tap for a few minutes should clear up the discoloration. Please avoid using hot water until the cold water runs clear.

Changes in water pressure: These fluctuations should be brief and will normalize once the process is complete.

Important Precautions

- 1. Prior to the scheduled flushing, we recommend storing some water for essential use to minimize any inconvenience during the procedure.
- 2. Avoid doing laundry during the hours when hydrant flushing is taking place in your area to prevent any staining of clothes due to the temporary water discoloration.
- 3. If you encounter any persistent water quality issues after the flushing period, please contact the Water Department immediately.

Shoreline Resiliency Committee News

The Greater Bridgman Shoreline Resiliency Committee (SRC) is hosting another Adopt-a-Beach Clean-Up Event at Weko Beach to coincide with The Alliance for the Great Lakes Day of Action when thousands of volunteers on all five lakes will be cleaning up shorelines as part of the International Coastal Cleanup. This September marks 20 years of litter data collection for The Alliance and the second time this year that Bridgman has contributed to the effort. More than 13 pounds of litter were collected in 30 minutes on Weko Beach during the SRC's Earth Day Event. Every piece was tallied and entered into a huge Great Lakes dataset that was shared with the Ocean Conservancy to become part of global data set that shines a spotlight on the plastic pollution reaching alarming levels in the lakes.

More than 11 million pounds of plastics enter Lake Michigan every year, according to statistics displayed in "The Blue Paradox" exhibit now running at Chicago's Museum of Science and Industry. Not only are microplastics being found in beer made with Great Lakes Water, recent studies have them showing up in the human bloodstream and lower respiratory tract. The average person could be ingesting a credit card's worth each week. Although American Marine Biologist Sylvia Earle has noted that we are at a tipping point, she maintains that "we still have the opportunity to tip things back in the right direction if we act now."

Join the committee in taking action at Weko Beach, where volunteers will have the opportunity to hear Deputy Executive Director and Senior Planner for the Southwest Michigan Planning Commission, Marcy Hamilton speaking about other pollution risks (they are not just plastics!) to our local water resources. The Great Lakes contain 84 percent of North America's fresh water and provide drinking water for more than 40 million people. She says everyone can and needs to play a role in improving and protecting our creeks, rivers, lakes, wetlands and Lake Michigan. She will highlight some specific projects to improve water quality in our area.

The SRC is planning to use funds received from the Creating a Culture of Resilience Capacity Building Grant awarded through The Michigan Department of Great Lakes and Energy's (EGLE) Water Resource Division to hire a zoning ordinance consultant to review options identified in Goal 17 of Bridgman's 2019 Master Plan. Consultants' proposals were requested by August 22nd. Meanwhile, the committee continues its collaboration with Michigan State University's Citizen Science Coastal-Change Monitoring Program, which began in Bridgman on Earth Day 2023. Local aviation expert Gary Blied sent his latest drone videos to the Coastal Processes and Geomorphology Lab in MSU's Department of Geography, Environment, and Spatial Sciences in August and Dr. Ethan Theuerkauf, who founded the monitoring program

in order to identify vulnerable shorelines where resiliency could be bolstered, is scheduled to speak at the 2024 Weko Beach Earth Day Event.

The SRC was formed in response to the city's participation in The Coastal Leadership Academy created by the Michigan Department of Environment, Great Lakes, and Energy's

Coastal Management Program and the Michigan Association of Planning. "The goal," says SRC chairman Gene Schoon, "is to learn all we can about what affects shoreline resilience to help the community make the best decisions possible." Property Maintenance Codes

from the Zoning Administrator, Brad Mattner

In the spring of 2023 the City of Bridgman adopted the most current version of the International Property Maintenance Code (IPMC). The IPMC is a set of regulations and standards developed by the International Code Council (ICC) to govern the maintenance and upkeep of existing buildings and properties. The IPMC is adopted and enforced by many local governments around the world to ensure that properties are adequately maintained, promoting public health, safety, and welfare. Here are some key reasons highlighting the importance of the International Property Maintenance Code:

- 1. Public Health and Safety: The IPMC establishes minimum maintenance standards for buildings and properties, addressing issues like structural integrity, sanitation, ventilation, fire safety, and other factors that can directly impact the health and safety of occupants and the surrounding community.
- **2. Property Preservation:** By setting standards for property maintenance, the IPMC helps preserve buildings and structures over time. Proper maintenance can extend the life of a property, preventing decay and deterioration and reducing the need for costly repairs or replacements.

3. Neighborhood and Community Improvement:

The IPMC plays a crucial role in improving the overall appearance and condition of neighborhoods and communities. By ensuring that properties are well-maintained and aesthetically pleasing, the code helps create a sense of pride in the community and can attract potential investors and residents.

- **4. Preventing Blight and Neglect:** Neglected or abandoned properties can become sources of blight, attracting crime, lowering property values, and negatively affecting the overall neighborhood. The IPMC helps prevent blight by requiring property owners to maintain their buildings and landscapes adequately.
- **5. Tenant and Resident Protection:** For rental properties, the IPMC often includes provisions that protect tenants and residents from substandard living conditions. It can address issues like heating, ventilation, sanitation, and pest control, ensuring that tenants have safe and habitable living spaces.
- **6. Legal and Insurance Compliance:** Compliance with the IPMC is often a legal requirement in many jurisdictions. Property owners must adhere to these regulations to avoid fines, penalties and potential legal liabilities. Additionally, insurance companies may consider the level of compliance with the code when determining coverage and premiums.

- 7. Emergency Preparedness: Proper maintenance of buildings can play a vital role in emergency preparedness. - **8. Uniformity and Consistency:** The IPMC provides a standardized set of regulations that promote uniformity and consistency in property maintenance practices. This ensures that all properties within a jurisdiction are held to the same minimum standards, regardless of property type or location.

Remember, taking pride in your property doesn't mean you have to do everything yourself. It's about being proactive in addressing maintenance needs, seeking professional help when necessary and making conscious efforts to improve and beautify your space. When you take pride in your property, you are investing in your own well-being, creating a positive atmosphere for yourself and others and making a lasting impact on your community and future generations.

School Bus Safety Tips for Drivers: Stop Means Stop!

The majority of bus-related deaths and injuries involve pedestrians - mostly children - who are struck by a bus or injured when they are exiting the bus to cross traffic.

- Slow down and prepare to stop when a slowing bus has its overhead yellow lights flashing.
- Stop at least 20 feet away from buses when red lights are flashing, unless driving in the opposite direction on a divided highway.
- Slow down in or near school and residential areas.
- Look for clues-such as safety patrols, crossing guards, bicycles and playgrounds that indicate children might be in the area.
- Watch for children between parked cars and other objects.

Township News from Supervisor, Zach Carson

Dear Township Residents,

With summer in full swing, our crews have been hard at work mowing and

maintaining the sprinkler systems. As you may recall from my previous article, we're still striving to bring **broadband to our underserved residents**. Recently, the ROBIN grant was awarded to Midwest Energy & Communications (MEC), which could potentially provide high-speed broadband service to residents and businesses in Berrien County that currently lack access. We'll have more information on construction plans and schedules by early fall.

I recently attended the Michigan Township
Association Conference, where I participated in
several informative seminars. The **solar seminar**focused on building an ordinance that benefits
both the community and solar energy companies,
while still prioritizing safety, health, and welfare.
The **road department seminar** provided valuable
insights on fostering better relationships with local
road departments. Additionally, the **fire seminars**touched on topics like electric car and battery fires,
firefighter training rules and firefighter compensation.
After attending these seminars and listening to the
challenges faced by similar fire departments, I started
exploring ways to enhance our fire service.

As our community continues to grow, we're looking for ways to reduce our wastewater volumes. I urge all residents, if you have a sump pump, check to see where it is draining. If it IS draining to the sanitary sewer, it is important to reroute it to the outside of your home. This will help alleviate strain on the Townships' sanitary sewer system during large rain events. When it rains heavily, water infiltrates basements and sump pump pits, which then gets sent into the sanitary line and overloads the system. By correcting this, you can help ease the system and avoid costly upgrades.

To check if your pump is connected to the sewer, follow the line and see if it's connected to the rest of the plumbing in your home. If you need assistance, reach out to a plumber who can help you find a solution to correctly route it to the outside of your home. Thank you for doing your part to help our community and protect our environment.

Building & Zoning News from Building Administrator, Rich Kubsch

Here we are heading into fall already! I'm excited to keep you up to date with the latest happenings from the Planning Commission. At their July meeting, they reviewed two applications, one for **a new winery** and another for an **extension of the Warren Dunes Mobile Home Park**. The proposed winery was approved and will produce and market their products on-site. It's always good to see support for new ventures, and there were neighbors in attendance who were in favor of the winery. The extension of the mobile home park was also approved and will increase the number of homes available by 54 units, which will be a relief for those in need of housing in the great community of Lake Township.

The Planning Commission is still working on zoning ordinances, but they have completed the Master Plan. It will be sent to the Township Board, the Berrien County Planning Commission and neighboring communities. It will also be available to local residents through a public hearing. I hope you will attend.

The Commission has also been assigned to create and recommend ordinances for **solar requests** (commercial and residental) and **home rentals**. At this point, the goal would be to regulate home rentals through registrations and inspections by a trained inspector from the fire department. Inspections will ensure normal home use safety and code compliance.

If you'd like to stay informed, feel free to attend a scheduled meeting. They're open to the public and posted on the Township's website, **Lake-township.org**.

When purchasing a cremains container, please choose a size that will fit in inside the niche.

If you are **purchasing over 10 cemetery plots**, your request will be addressed by the Lake Charter Township Board of Trustees.



Water System News from Jeff Burkhard

Hello Everyone,

I hope everyone had a great summer. As you know, the season started off hot and dry. It's incredible how much our water pumpage can shift after just one day of rainfall. You might be curious about how much water we produce on a hot, dry summer day. Well, we averaged 2.25 million gallons DAILY for the month of July, with a max of 2.94 million gallons. It will be interesting to see how we finish out the rest of summer; it all depends on how much rain we get. We are very fortunate to have such an abundant source of high-quality water to draw from.

I'd like to mention **two items of importance** that have to do with

our distribution system. We mailed a

letter to 120 select customers to gather
information about your service line to your home.

We need to update our records to comply with our
regulatory agency's mandate created by the revision of
the Environmental Protection Agency Lead & Copper
rule. If you received one of these letters, please respond
with the information as requested, or we will need to
contact you for this information. The other item is our **residential cross-connection inspection program**.

We will
Watch your mail for an inspection date. Again, this is

another mandate that we must comply with. We began residential cross-connection inspections last year and will have completed all residential inspections by this fall. If you haven't been visited by Hydro Corp (the comany that we contracted with), you can expect to have a representative stop by to conduct this exterior inspection soon. They will be looking at exterior faucets, lawn WE AVERAGED irrigation systems, and any condition that could create a cross-connection to the 2.25 mil public water system. For example, you may have a backflow device on your lawn GALLONS / DAY irrigation system, which must be tested periodically.

If you haven't visited our water system website, I would encourage you to do so at LakeCharterTownshipWater.org. The home page has a red tab to sign up for alerts. This can be helpful in an emergency or other unscheduled water outages. Whenever you pay your water bill or contact the township hall, please update your contact information in case we need to contact you.

We will begin working on our 2024 budget soon, and I would like to share some of the items we budget

for that you might not be aware of. You can imagine we have many pumps at the plant that process water and need to be rebuilt over time. We budget \$85,000 annually for pump repair and replacement. We operate a lab for bacteriological and water quality testing, for which we budgeted \$31,000. Chemical costs to treat the water have increased significantly (budgeted \$92,500). Electrical costs are budgeted at \$200,000. These amounts are just a few, and we have many expenses to maintain the treatment plant. Over time, equipment needs to be replaced because repair parts are no longer

available or the cost to repair exceeds the replacement value. Costs continue to rise, and we make every effort to be good stewards of the available funds.

CITY OF BRIDGMAN 2023 FALL CLEANUP SCHEDULE

Bagged Leaves & Brush Pick-up are indicated in GREEN on the calendar. The city requires the use of biodegradable paper leaf bags. City workers will not pick up leaf bags made from any other material. Please limit to yard cleanup.

City workers will spend no more than 15 minutes at each property. If you have a large quantity of brush, arrangements can be made for you to haul the brush to the city composting site. Commercial tree removal/trimmings will not be picked up and should be disposed of by the tree service hired. Last day for the season will be November 20th. Service will resume April 2024

Leaf & brush burning within the city is prohibited

<u>Curb-side Leaf Pickup</u> is indicated in <u>ORANGE</u> on the calendar. The leaf vacuum will begin on Mondays on the east side of the city and complete one pass per week through the city. Leaves must be raked to the roadside/curb. To prevent flooding from leaves clogging the storm drains DO NOT rake leaves into roadways.

<u>Christmas Tree Pick Up</u> – January 3 and 10, 2024 (weather permitting)

Large Trash Pick Up — September 13 & 20. Items not accepted include those larger than a refrigerator, tires, and construction material. Refrigerators and air conditioners must have the freon removed with a tag attached indicating as such. A complete list of accepted items is available on the city's website and at City Hall.

Republic Services also will pick up your extra-large items for a fee. To schedule such a pickup, call Republic Services at (269) 465-3773.
